## Supplement to the Marshalled List of Amendments selected for Stage 3

55 After section 10A, insert—

*<Acoustic deterrent devices: requirement to report*

#### **Acoustic deterrent devices: requirement to report**

- 5 (1) The Scottish Ministers must as soon as practicable, and no later than 1 March 2021, lay a report before the Scottish Parliament on whether existing provision in relation to animals and wildlife is sufficient to manage the use of acoustic deterrent devices on land constituting a fish farm.
- (2) A report under subsection (1) must include—
- 10 (a) information on the use made of acoustic deterrent devices on Scottish fish farms,
- (b) any known impacts that the use of acoustic deterrent devices has on marine mammals,
- (c) consideration of whether the use of acoustic deterrent devices on Scottish fish farms is sufficiently monitored,
- 15 (d) consideration of the circumstances in which Scottish fish farm operators using acoustic deterrent devices may commit an offence under regulation 39 of the Conservation (Natural Habitats, &c.) Regulations 1994 (SI 1994/2716), and
- (e) any future plans for regulation of the use of acoustic deterrent devices.>
